Chairman Johnny Ravenell asked for a motion on the minutes. Councilman Heyward Livingston motioned that the minutes of the sessions of the Orangeburg County Council on the above dates be approved as written. Councilman Harry Wimberly seconded the motion. Motion carried. (3-0-0).

1. MAINTENANCE ABANDONMENT REQUEST ON TRIPLE ROAD

Mr. Henry Summers advised he spoke with the Orangeburg School District Transportation Director, and the report that was given back to him was it would not be in the best interest to move the buses and Mr. James Howard advised he did speak with Vice-Chairwoman Cooper-Smith about it.

Vice-Chairwoman Cooper-Smith advised that she did speak with Mr. James Howard who is the Transportation Director and there were three school buses, two school district buses, and one OCAB bus.

Chairman Johnny Ravenell yielded to Administrator Young. Administrator Young advised he had spoken to Mr. James Howard and he did advised they could come up with an alternative but it was their preferred route to leave Triple Road open.

Chairman Johnny Ravenell recognize Dustin Fogle.

Dustin Fogle advised the road was only fifteen (15) feet wide and one vehicle can barely get down this road with a school bus.

Councilman Harry Wimberly, asked how many roads in that area do the County maintain?

Vice-Chairwoman Cooper-Smith advised this was the only road and it was up for paving.

Councilman Harry Wimberly advised even if the County abandon maintenance the road it still does not close the road and it will still be open to the public.

Chairman Johnny Ravenell advised the citizens the road is still going to be open and they could not put a gate up or block the road from the public.

Chairman Johnny Ravenell advised he was not in favor of abandoning maintenance on Triple Road because of the school buses that travel the road and the numbers on the count study. The traffic is going through for a reason.
