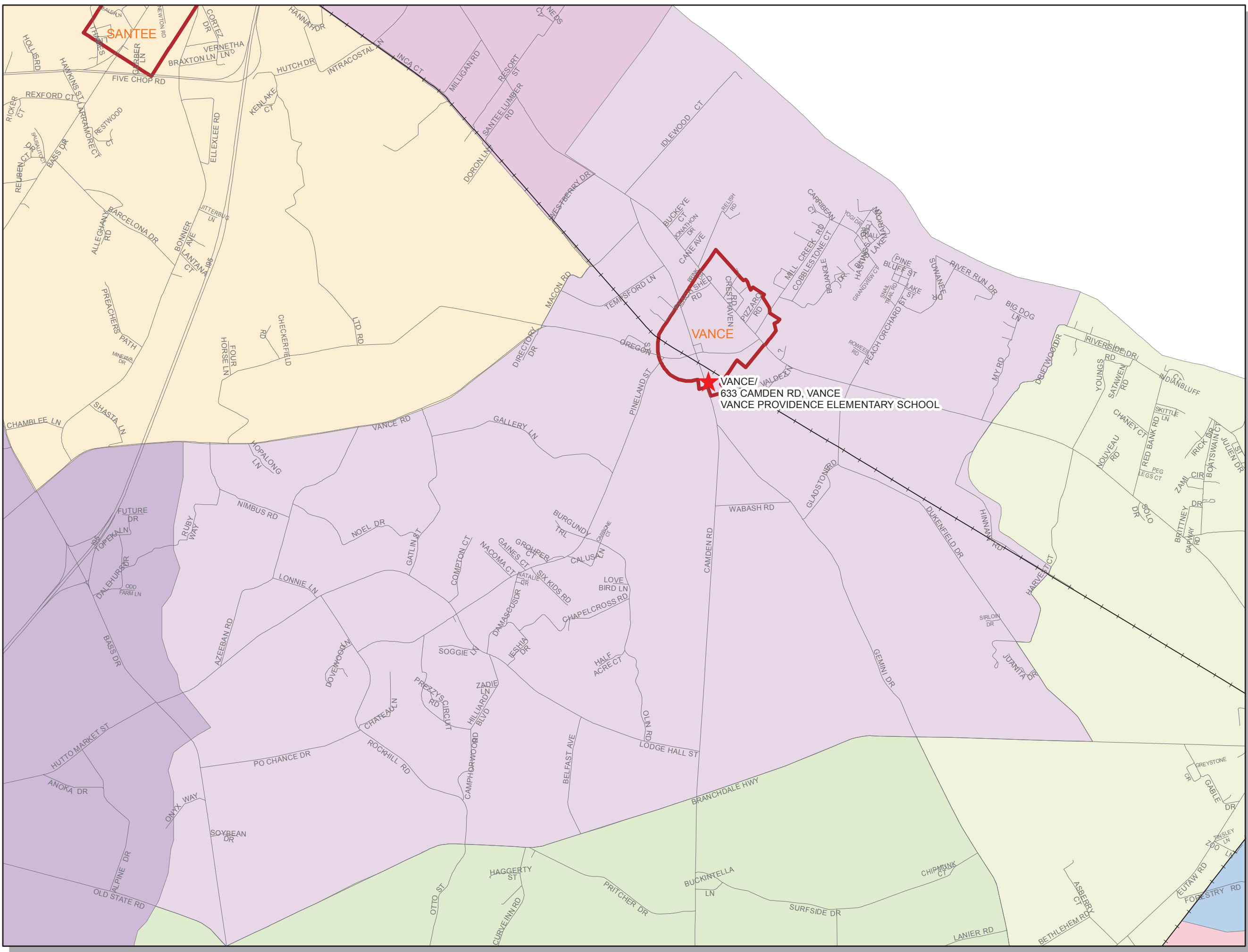
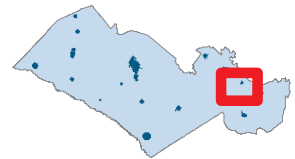


POLLING LOCATION MAP
