In connection with this acknowledgement, the submitting contractor/vendor represents that (1) contractor/vendor is aware that the Project that is the subject of this procurement is to be paid for in significant part by a governmental funding agency other than Owner (herein the "Funding Agency"), (2) that the funding by the Funding Agency is contingent upon timely completion of the Scope of Work, and (3) failure to timely complete the Scope of Work will jeopardize the Owner's ability to fund the Project, up to and including the adverse effect of Owner losing all Project funding committed by the Funding Agency.

As a result, Owner will require that the contract between the Owner and the successful contractor/vendor contain an agreed upon figure in the following range for the contractor's/vendor's failure to timely complete the Project (herein "Liquidated Damages"): a negotiated amount in the range of \$1,000 to \$25,000 per day for each day past the deadline it takes the successful vendor to complete the Scope of Work.

1.02 The undersigned Bidder proposes and agrees, if this Bid is accepted, to enter into an Agreement with Owner in the form included in the Bidding Documents to perform all Work as specified or indicated in the Bidding Documents for the prices and within the times indicated in this Bid and in accordance with the other terms and conditions of the Bidding Documents.

**ARTICLE 2 - BIDDER'S ACKNOWLEDGEMENTS**

2.01 Bidder accepts all of the terms and conditions of the Instructions to Bidders, including without limitation those dealing with the disposition of Bid security. This Bid will remain subject to acceptance for sixty (60) days after the Bid opening, or for such longer period of time that Bidder may agree to in writing upon request of Owner.

**ARTICLE 3 - BIDDER'S REPRESENTATIONS**

3.01 In submitting this Bid, Bidder represents that:

A. Bidder has examined and carefully studied the Bidding Documents, the other related data identified in the Bidding Documents, and the following Addenda, receipt of which is hereby acknowledged.

B. Bidder has visited the Site and become familiar with and is satisfied as to the general, local and Site conditions that may affect cost, progress, and performance of the Work.

C. Bidder is familiar with and is satisfied as to all federal, state and local Laws and Regulations that may affect cost, progress and performance of the Work.

D. Bidder has carefully studied all: (1) reports of explorations and tests of subsurface conditions at or contiguous to the Site and all drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the Site (except Underground Facilities), which have been identified in Paragraph 4.02 of General Conditions, and (2) reports and drawings of Hazardous Environmental Conditions that have been identified in Paragraph 4.06 of General Conditions as containing reliable "technical data."

- E. Bidder has obtained and carefully studied (or accepts the consequences for not doing so) all additional or supplementary examinations, investigations, explorations, tests, studies and data concerning conditions (surface, subsurface and Underground Facilities) at or contiguous to the Site, which may affect cost, progress, or performance of the Work or which relate to any aspect of the means, methods, techniques, sequences, and procedures of construction to be employed by Bidder, including applying the specific means, methods, techniques, sequences, and procedures of construction expressly required by the Bidding Documents to be employed by Bidder, and safety precautions and programs incident thereto.
- F. Bidder does not consider that any further examinations, investigations, explorations, tests, studies, or data are necessary for the determination of this Bid for performance of the Work at the price(s) bid and within the times and in accordance with the other terms and conditions of the Bidding Documents.
- G. Bidder is aware of the general nature of work to be performed by Owner and others at the Site that relates to the Work as indicated in the Bidding Documents.
- H. Bidder has correlated the information known to Bidder, information and observations obtained from visits to the Site, reports and drawings identified in the Bidding Documents, and all additional examinations, investigations, explorations, tests, studies, and data with the Bidding Documents.
- I. Bidder has given Engineer written notice of all conflicts, errors, ambiguities, or discrepancies that Bidder has discovered in the Bidding Documents, and the written resolution thereof by Engineer is acceptable to Bidder.
- J. The Bidding Documents are generally sufficient to indicate and convey understanding of all terms and conditions for the performance of the Work for which this Bid is submitted.
- K. Bidder will submit written evidence of its authority to do business in the state where the Project is located not later than the date of its execution of the Agreement.

#### **ARTICLE 4 – BIDDERS CERTIFICATIONS**

4.01 Bidder further represents that:

- A. This Bid is genuine and not made in the interest of or on behalf of any undisclosed individual or entity and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation.
- B. Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid.
- C. Bidder has not solicited or induced any individual or entity to refrain from bidding.
- D. Bidder has not sought by collusion to obtain for itself any advantage over any other Bidder or over Owner.
- E. Bidder has not engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the Contract. For the purposes of this Paragraph 4.01.D:
  - 1. “corrupt practice” means the offering, giving, receiving, or soliciting of an thing of value likely to influence the action of a public official in the bidding process;

2. "fraudulent practice" means an intentional misrepresentation of facts made (a) to influence the bidding process to the detriment of Owner, (b) to establish bid prices at artificial non-competitive levels, or (c) to deprive Owner of the benefits of free and open competition;
3. "collusive practice" means a scheme or arrangement between two or more Bidders, with or without the knowledge of Owner, a purpose of which is to establish bid prices at artificial, non-competitive levels, and
4. "coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the bidding process or affect the execution of the Contract.

**ARTICLE 5 - BASIS OF BID**

5.01 The undersigned, as Bidder, hereby declares that the only persons interested in this as principal, or principals, is or are named herein and that no person other than therein mentioned has any interest in the bid or in the Construction Contract to be entered into; that this bid is made without connection with any other person, company, or parties making a bid; and that it is in all respects fair and in good faith without collusion or fraud.

The Bidder has carefully examined the Contract Documents, including without limitation, the site of work, all drawings, the General Conditions, Technical Specification, the contract, etc. for the construction of the above named project, and in compliance with this Bid Documents and Package will provide all necessary machinery, tools, apparatus, and other means of construction, and do all the work and furnish all materials called for in accordance with the requirements of the County of Orangeburg and the true intent of the Contact Documents.

The above lump sum price shall include all labor, materials, bailing, shoring, removal, overhead, profit, insurance, etc., to complete the finish work as stipulated in the Bid Documents.

Lump sum price have been computed in accordance with Article 11 of the General Conditions.

The Bidder further understands that all supplies and materials covered by this Bid shall be new and of the best quality and the highest grade workmanship. The Bidder certifies by the submission of the Bid that there has been no violation of copyrights or patent rights in manufacturing, producing, or selling the product or services shipped or ordered as a results of this Bid. The successful bidder shall, at their own expense, defend any and all action or suits chagrin such infringements, and will save Orangeburg County, its officers, employees, and agents harmless from any and all liability, loss, or expense occasioned by any such violation.

5.02 General Allowances: The Base Bid shall include allowance for all items detail within this section. The Bidder shall provide unit cost in spaces provided in the "General Allowances Table" below.

- A. Electrical Power Supply Service Allowance: For coordinating, furnishing and installing of the new Electrical Transformer by Tri-County Electric Cooperative to provide feed power to the Goodbys Regional Wastewater Treatment Plant and any necessary power supply service location at the Sanders Pointe Land Application Site. All Bids shall include a amount of **\$ 10,000** allowance for the Electrical Power Supply Service and shall only be ordered if Engineer deems necessary associated with the direct costs from Tri-County Electric Cooperative to the successful bidder.
- B. Undercut Excavation and Removal of Unsuitable Soil Allowance: Undercut excavation and removal of unsuitable soil as determined by the data provided in Section 00 31 32 - Geotechnical Data and as determined by the Geotechnical Engineer in the event that the Engineer or contractor request clarification on this matter. This allowance shall only be ordered if Engineer and Geotechnical Engineer deems necessary base on site conditions to the successful bidder.
- C. Select Backfill of Suitable Soil Allowance: Select backfill of suitable soil as determined by the data provided in Section 00 31 32 - Geotechnical Data and as determined by the Geotechnical Engineer in the event that the Engineer or contractor request clarification on this matter. This allowance shall only be ordered if Engineer and Geotechnical Engineer deems necessary base on site conditions to the successful bidder.
- D. Office/Lab/Maintenance Building Interior Cabins and Equipment Allowance: For the coordinating, furnishing and installing of all interior cabins and equipment detailed on Construction Drawing Sheet A4. All Bids shall include a amount of **\$ 60,000** allowance Interior Cabins and Equipment and shall only be ordered if Engineer and Owner deems necessary to the successful bidder.

The extension of Bidder's unit costs times estimated quantities shall be included in Bidder's Base Bid. Quantities are estimates and are not guaranteed; they are solely for comparing Bids and establishing the Base Bid amount. Bidder understands that the allowance items are for work to be performed only as ordered by the Engineer. Final payment to the Contractor shall be based on the bid unit prices applied to the actual quantity of work performed by the Contractor. The final contract price will be adjusted up or down by change order to reflect higher or lower actual quantities. Unit bid prices that do not reflect fair market value of the work to be performed may be just cause for the owner to reject the proposal as non-responsive.

- 5.03 Major Bid Alternative: The Base Bid shall include completed project, in the event the owner elects or is required to reduce the scope of some major cast-in-place concrete structures (Sequencing Batch Reactor [SBR] – Future Train) including but not limited to related process piping, valves, other necessary components, labor, coordination, profit, overhead, etc. as described within the Construction Plans (See Sheets M5, S114, and S115).
