The System will utilize the latest technology standards in the emergency notification industry as a minimum standard. Individual respondents may note enhancements beyond these minimum standards as available at the deployment of the technology. We request that the selected vendor be able to provide a system that is Web based, provides for a secure login from any hand held device, (i.e., Smart Phones, I Phones, I Pads, Laptops, Desktops, etc) for operation of the system. The system should be able to place at minimum 100,000 telephone calls and 100,000 SMS SMPP text messages an hour. The system will be able to utilize a preset notification priority during emergency notifications.
