Scope of Work

Small commercial roof replacement work needed at the Edisto Drive Senior Citizens Community Center, located at 2020 Sharperson St, Orangeburg South Carolina. Building is about 3500 square feet. Contractor is required to have a valid license as a commercial roofing contractor with the state of South Carolina.

Contractor has responsibility of tearing off and replacing shingles, felt and making any necessary repairs to the underlayment. Shingles are to be black, (30) thirty year architectural style shingles on the entire roof, replace all pipe flashings and install shingle overlay ridge vents. Work shall be conducted according to the manufacturer's installation instructions. The work shall include the furnishing of all supervision, labor, materials, and services required to make necessary repairs.

Work must be completed within four (4) weeks from award of project.

Warranty

Contractor has responsibility of site clean-up, hauling away and properly disposing of all debris.

Provide manufacturer's written warranty, thirty (30) year minimum. Contractor must furnish a written warranty on labor for a period of five (5) years.



Work must be performed during normal business hours 8:30-5:00 M-F only. Vendor must adhere to all safety guidelines and regulations of occupancy of staff, citizens and vehicles around property.
