

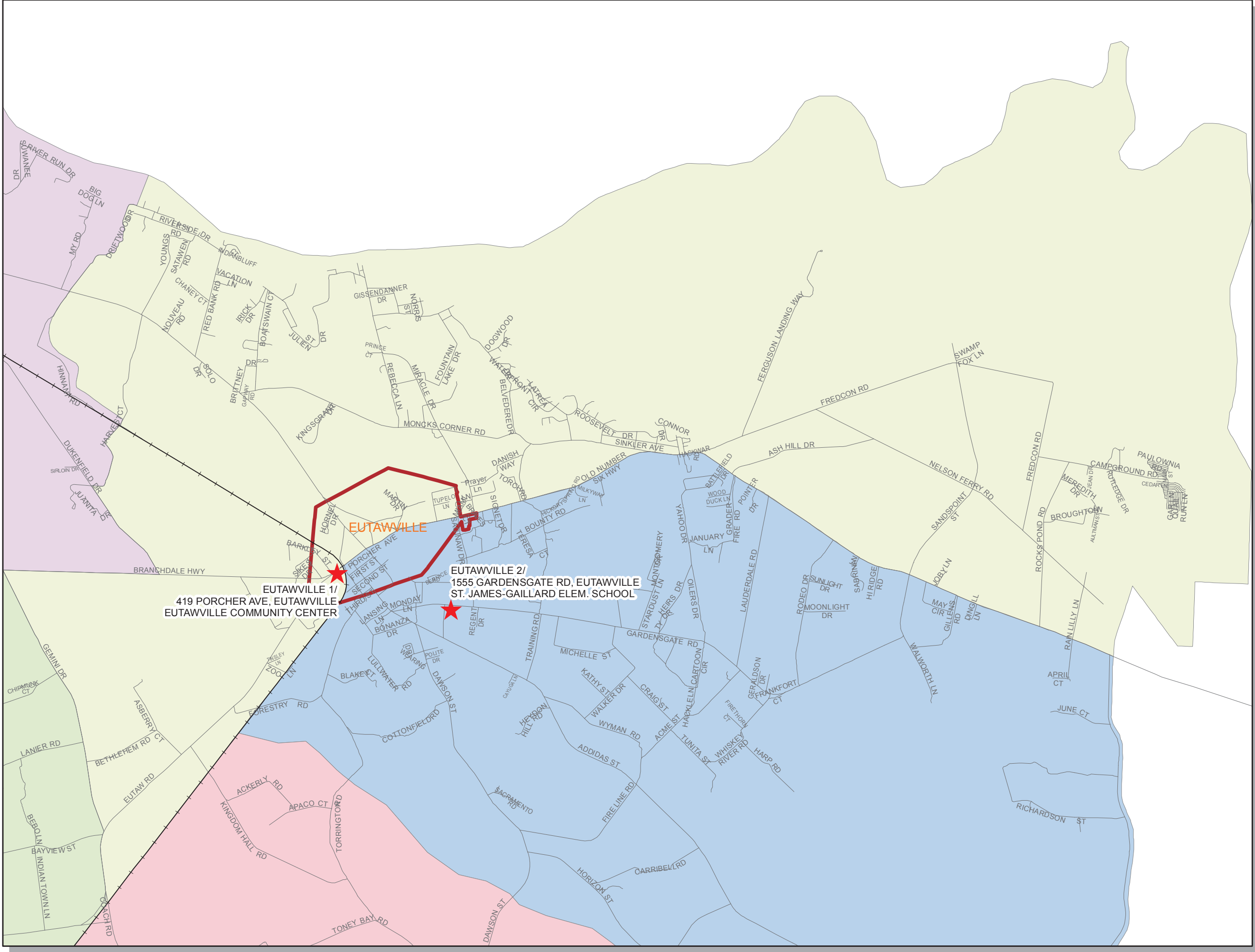
POLLING LOCATION MAP
